**Code of Conduct for Members**

As a member or co-opted voting member I have set out below the **Disclosable Pecuniary Interests** (Part A) and the **Other Registrable Interests** (Part B) and Gifts and Hospitality (Part C) which I am required to disclose under the council's Code of Conduct for members and co-opted voting members, and I have put "none" where I have no such interests under any heading.

**"Disclosable Pecuniary Interest"** means an interest of yourself, or of your partner if you are aware of your partner's interest, within the descriptions set out in Part A of the Table below.

**"Partner"** means a spouse or civil partner, or a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners.

**Other Registrable Interest** means an interest as set out within the descriptions set out in Part B of the Table below.

**NOTE:** Members and co-opted members must register Disclosable Pecuniary Interests and Other Interests with South Gloucestershire Council's Monitoring Officer within 28 days of the election to office.

<sup>3</sup> 'Land' excludes an easement, servitude, interest or right in or over land which does not give the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/civil partners (alone or jointly with another) a right to occupy or to receive income.
