- Community groups and organisaitons will have access to community growing
- The area will be open for use by Southern Brooks and Face who are active with social provision in the area
- It will provide a space that is beneficial to health and mental wellbeing for the users
- The tree Nursery will create an income stream which once established will support the locations development
- It will be an area where events can take place for local school children
- If developed correctly it can become a local focal point to visit selling plants (income) to local people at discounted costs
- An area that is mainly unused will become productive We are aware the local people are used to having a firework display, ideally the location could be moved but if that is not the case then with careful planning, we can still achieve the above, but we will have to plan carefully. We do think that potential community benefits might outweigh the bonfire site which is used just once a year but do appreciate that this is a potential problem.
- The cost-of-living crisis which is set to continue will mean more local people will need access to fresh healthy local food. This also has a positive environmental footprint aspect

Comments

1. There is a good area for a community orchard - I noticed that the ground was very damp and the planting of trees would absorb excess water - Negatives

Proposal

Does not have natural foot fall so community might not be that aware. Positives - area large enough to create a brilliant community resource where future events could be held and that will provide local food banks and community kitchens with fresh fruit.

2. Planting would work by planting rows of Trees creating walkway of blossom, there is enough room to allow for moving but OPM would also (with community members develop wildflower areas within the footprint of the orchard and provide Parish Council with Moving plan) - this aspect applies to 1 above as well.

The orchard can be planted in January/February of 2023

Some considerations - We could we your approval plonk a couple of polytunnels in Pretoria Allotment location and that would be beneficial, but we believe it is better to create something that is mean that will have longevity but more importantly will provide an area that becomes a really beneficial local asset.

Patchway - Ecological Survey and Report
