10/11/2020-No 1. To receive the apologies for absence.

Apologies for absence were received from Cllr J Buddharaju.

10/11/2020-No 2. Declarations of Interest

Any member having a disclosable pecuniary interest in a matter to be discussed should declare it during the meeting as specified in the Code of Conduct required by the Localism Act 2011 Section 27 and should leave the room while the matter was discussed. There were no requests for dispensations.

RESOLVED: It was unanimously agreed to approve the minutes as a true and accurate record.

10/11/2020-No 4. To receive and consider the Financial Reports for October 2020.

a) Bank Reconciliation and Bank Statements

The committee approved the reconciliation and statements.

b) Income and Expenditure Report

The committee noted the income report and no queries were raised.

c) Monthly Summary of Accounts

RESOLVED: The committee unanimously agreed the financial reports. It was **further resolved** that an item should be added to Full Council to discuss the Patchway Sports and Social Club rent.

d) Outstanding Payments due to the Council.

Noted.

10/11/2020-No 5. To review the budget for 2021/2022 and make any amendments necessary on the following cost centres:

a) Centre 100 - Income

No changes were made on this cost centre.

b) Centre 110 - Establishment

It was agreed that 4200 'Broadband' should be raised from £500 to £900.

c) Centre 120 - Civic/Democratic

It was noted that the surplus in the Civic Fund should be retained as an Earmarked Reserve at year end.

d) Centre 200 - Callicroft House

No changes were made on this cost centre.

e) Centre 210 - Casson Centre

No changes were made on this cost centre.

f) Centre 220 – Burials

No changes were made on this cost centre.

g) Centre 300 – Patchway Community Centre

No changes were made on this cost centre.

h) Centre 310 - Coniston Community Centre

No changes were made on this cost centre.

i) Centre 400 - Youth & Community

It was agreed that 4869 'Youth Development' should be raised from £10,000 to £15,000.

j) Centre 410 - Grants

No changes were made on this cost centre.

k) Centre 900 – Capital and Projects

No changes were made on this cost centre.

I) Centre 910 - Professional Fees

It was noted that this centre was now deleted and all the budget headings would be included into the capital and projects cost centre.

After the amendments from the Finance Committee the current precept stands at £632,766.

10/11/2020-No 6. To consider the installation costs of installing Virgin Media Broadband at Scott Park and agree any actions.

The Council received the quotation from Virgin Media for the 'civils' work and it was agreed that this was very costly. The RFO presented quotations from three different suppliers for mobile broadband from Vodafone, Three and 02. **RESOLVED:** It was unanimously agreed that a 12 month contract at £27.50 per month should be taken out to enable the Clerk and Deputy Clerk and RFO to work effectively down Scott Park.

10/11/2020-No 7. To consider the use of the CCLA Public Sector Deposit Fund and agree any actions.

The RFO talked through this item. Due to the NatWest Account not bearing too much interest, the Council should seek to place more monies in into the CCLA Public Sector Deposit Fund. The RFO would retain 6 weeks of revenue expenditure in the NatWest Account with the rest being invested into the CCLA Public Sector Deposit Fund and being drawn down by the RFO when needed.

RESOLVED: It was unanimously agreed to recommend that Patchway Town Council invests more money into the CCLA and delegates responsibility to the RFO for the transferring of funds.
