  - **RESOLVED:** It was unanimously agreed to raise an objection to this planning application. The committee will object to this application on the grounds of over-development in that area and the frequency of guest house visitors would not be the same as up to eight people living there. The committee would also object on parking issues, access from the A38 and the issues that the bus lane causes for the proposed tenants.
- c) P23/01784/F Erection of 1no. storage building, 1no. guards lodge, 2.4m high boundary fence and gates and installation of 3no. extraction outlets to existing building. Unit 1 Highwood Road Patchway South Gloucestershire BS34 5DJ. RESOLVED: It was unanimously agreed to raise no objections to the above application.
- d) P23/01897/CLP Conversion of existing garage to form garden room/gym 25 Thirlmere Road Patchway South Gloucestershire BS34 5PD.
   RESOLVED: It was unanimously agreed to raise no objections to the above application.
- e) P23/01928/CLP Installation of 1no rear dormer to facilitate loft conversion. 68
   Cavendish Road Patchway South Gloucestershire BS34 5HJ.
   RESOLVED: It was unanimously agreed to raise no objections to the above application.

  - i. P23/02047/F Erection of 1 no. dwelling with new access, parking and associated works (amendment to previously approved scheme P21/3947/F). Land At 29 Ravenscourt Road Patchway South Gloucestershire BS34 6PL. RESOLVED: It was unanimously agreed to raise no objections to the above application however it was agreed to ask South Gloucestershire Council to ensure that the use was for domestic purposes and would not be for a HMO application.

We are offering grants of up to £4,000 to community groups, community organisations and town and parish councils who can introduce and maintain forward-thinking planting approaches.

#### Recycling at Callicroft House and Casson Centre

Patchway Town Council is committed to being a sustainable and environmentally responsible Council. The Council has an active Local Nature Action Plan and has progressed many initiatives to make Patchway a town that is proud and responsible for its environment.

The Council currently disposes of all its waste from Callicroft House and the Casson Centre through its bi-weekly mixed waste skip collection with all other waste collected from across the town including from litter bins and dog waste bins. The waste is disposed through Smiths Waste Management in Gloucester. Due to the mixture of different waste in the skip, this is not possible to be sorted and recycled.

Waste from Callicroft House and the Casson Centre is generally recyclables including paper, cans, cardboard, tetra paks and plastics. The Link Club are now a regular user of the Casson centre and produce recyclable waste through providing their clients with drinks cans, sandwich wrappers etc which can all be recycled. Other users also produce waste that could be recycled.

South Gloucestershire Council offer an affordable weekly and bi-weekly service for parish and town councils to collect recyclables.

2 x 240 litre recycling bins for paper, cans, cardboard, tetra paks and plastics would cost £510 p/year for a weekly collection, or £255 p/year for a bi-weekly collection. At this stage, it could be difficult to work out if a weekly or biweekly collection is needed though the service from South Gloucestershire is flexible.

The Council would also need to purchase a recyclables bin for Callicroft House and the Casson Centre for an approximate cost of £25 each.

This modest investment would go a long way to strengthening The Council's commitment to the environment and reduction of waste going into landfill.

It would also reduce the amount of waste going into the general skip which could be monitored in terms of a potential opportunity of needing a smaller and cheaper skip into the future.
