The committee considered the costs of the contract and would like further information before making a decision.

**RESOLVED:** It was agreed by a majority, with one abstention, to write to DCK Accountancy to ask them for the professional indemnity insurance as well as clarifying what qualifications the staff held. It was noted that once the information had been obtained, then this would quote would be re-considered.
